- Digline's office is open 7 days a week. Calls have increased with the new season and the number of homeowners calling in located requests on a Saturday or Sunday has greatly increased compared to March 2018. (83 calls in 2018 compared to 183 in March of 2019)

- Ticket volume for March 2019 is 10.5% over March 2018. Year to date, the in-bound locate requests are 17.5% over 2018. Digline staff is busy, which means that the utilities, excavators and locators are even busier. Just a reminder: you can enter locate requests online at your convenience. Go to Digline.com and click on "Request a Locate" in the upper right corner of the screen. If you do not have a contractor ID# or don't remember your password, contact Digline and they will help you with that information. There is also an online manual that walks you through the process of entering a locate request online.
- A few reminders for excavators:
  - Please Premark the area of excavation. It makes it easier for the locators to find and mark the correct areas to be located.
  - Make sure to wait the full 2 business days before beginning excavation and verify that all known utilities in the area have been marked.
  - $\circ$  Make sure you call in your own locate request. Do not work off of someone else's ticket.
- Welcome USIC Locating to Eastern Idaho! They are now locating for several utility members including Rocky Mountain Power and Comcast. Effective March 29, 2019 at 1 a.m., USIC began locating for these facilities. If you need to contact USIC, call their dispatch at 800-778-9140. This number is answered 24 hours a day, 7 days a week.
